

REQUIREMENTS TO MAINTAIN AN ACTIVE FLORAL DESIGN JUDGES CERTIFICATE - 2025

To maintain an Active Floral Design Judges Certificate a Judge is expected to abide by the requirements stipulated by B.C. Council of Garden Clubs which are listed below and may be revised when necessary.

Floral Design Judges are responsible for keeping up to date with current information and evolving trends in Floral Designs. What are you doing to keep your skills current?

1. Judges are expected to belong to, and be a participating member of, one of the following Judges Associations and/or Floral Design Clubs; currently:
 - i. The Okanagan Floral Art and Horticulture Judge's Association.
 - ii. The Society of Horticultural and Floral Design Judges of B.C.
 - iii. The Vancouver Island Horticulture Judges Group.
 - iv. B.C. Floral Art Society.
 - v. Buds and Flowers Floral Art Club
 - vi. Floral Artists of the Fraser Valley.
 - vii. Mid Island Floral Art Club.
 - viii. Okanagan Floral Art Club.
 - ix. Victoria Floral Artist Guild.

2. In order to keep up to date a Floral Design Judge is expected to continue to enter exhibits in shows, attend workshops or symposiums or be a presenter of demonstrations or create a show schedule.

Judges are required to complete **two** of the following options annually.

Please note that judging a show is not a requirement and does not fulfill any of the options below.

- a. Enter one (1) Floral Design Exhibit in a judged public show (not a club meeting).

And/ Or

- b. Participate in (1) Floral Design Workshop for Judges. (by a Qualified floral designer ie AIFD or CAFA)

And/Or

- c. Participate in (1) Floral Design Symposium for Judges.(ie Chilliwack Gala, Judges Meeting, NAFAS Modules)

And/Or

- d. Be a Presenter of (1) Demonstration on Floral Design.

And/Or

- e. Create (1) Show Schedule for a Public Show (not a club meeting show schedule).

3. A Floral Design Judge must allow their contact information to be put on the B.C. Council of Garden Clubs website.
